

The Agoranomos as Civic Official




Attalids: the *panêgyris* of Apollo Tarsênos

A Working Hypothesis

Ilion's honors for three brothers from Tenedos, c. 300:

*Syll.*³ 355, lines 1-7

Τεισάνδρωι Αισχίνηι Χαρόππηι
Νικασιδίκωι Ἀριστοξένου παισὶ Τε-
νεδίοις προξένοις καὶ εὐεργέταις
αὐτοῖς καὶ ἐγγόνοις Ἰλιεῖς ἔδοσαν
ἀτέλειαν πάντων· καὶ ὅς ἂν ὦνῆται
παρὰ τούτων ἢ πωλῆι πρὸς τούτους, ἀ-
τελῆς ἔστω τοῦ τέλους·

“To Teisandros, Aischines, Charoppes, and Nikasidikos, the children of Aristoxenos, Tenedians, as proxenoi and benefactors, to them and their descendants, Ilion gave complete tax immunity. **And whoever should buy from them or sell to them, should be exempt from the (relevant) tax.**”

Part II: “Access”

Antiochus III to Sardis, 213 BCE

ἀπολύομεν δὲ ὑμᾶς καὶ τοῦ ἐνοικίου οὗ τελεῖτε ἀπὸ
τῶν ἐργαστηρίων, εἴπερ καὶ αἱ ἄλλαι πόλεις μὴ
πράσσονται.

We release you from the *enoikion* that you pay
on the *ergastêria*, if indeed it is true that the
other cities do not pay it.
